R2 - RESIDENTIAL SERVICE RATE SCHEDULE

I. Rate Designations

Rate No. 134

II. Applicability

Separately metered out buildings, garages, pumps, etc. located and billed to the same or adjacent property of an existing residential dwelling already metered and within the service limits of CRMU. Customers are prohibited from connecting a distributed generation resource to this rate class.

Customers who have their meter turned off and back on within a 12-month period will pay the minimum monthly charges, applicable to the customer, for the months while service was not being used.

Applicability Detail

Available to separately metered residential structures where there is no dwelling unit (garages, barns, pumps, etc.). Must be located on the same property or adjacent property to an existing residential dwelling already metered and the bill must be to the same customer. Service will be furnished to structure at 60 Hertz, single phase service at a nominal operating voltage of 120/240 volts furnished through one meter for domestic purposes only including lighting, small domestic appliances, water heating, supplemental space heating, refrigeration, cooking and domestic single phase motors rated 5 HP or less. Service to multiple dwelling units or an apartment house through a single meter is not permitted.

A residential dwelling is defined as any structure which wholly used or intended to be used for private living or sleeping by human occupants and as any habitable building, room or group adjoining habitable rooms located with a dwelling and forming a single unit with facilities which are to be used for living, sleeping, and the cooking and/or eating of meals. This includes SEPARATELY METERED single family dwellings (including incidental farm usage supplied through the same meter), condominiums/townhouses, two-family dwellings (duplexes), multiple family dwellings (contains three or more dwelling units), efficiency apartment units. Any apartment or living unit which has separate, permanent kitchen facilities shall be considered as one single, private residence for application of this rule.
